"Albertine Prize Ticket Giveaway" Contest

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1. CONTEST PERIOD: Albertine Prize Ticket Giveaway ("Contest") begins at 11:59 PM Eastern Standard Time ("EST") on April 14, 2017 and ends at 11:59 PM EST on April 30, 2017 ("Contest Period"). Sponsors: The Cultural Services of the French Embassy (Mission Culturelle et Universitaire française aux états-unis) and Albertine Books, both located at 972 Fifth Avenue, New York, NY 10075 and Bookwitty.com [Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.]
- **2. ELIGIBILITY:** The Contest is only open to legal residents of the 50 United States and District of Columbia who are at least eighteen (18) years old as of the date of entry. Employees of the Sponsor, The Cultural Services of the French Embassy (Mission Culturelle et Universitaire française aux états-unis), Air France and their affiliates/subsidiaries/joint-venture partners, SkyTeam, or any other party associated with the development or administration of this Contest, and the immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household as such employees, are not eligible to enter or win. Individuals who have won any contest or sweepstakes in the last 3 years sponsored by Air France or KLM, or any contest or sweepstakes where the prize awarded was provided by Air France or KLM, are not eligible to enter this promotion.
- **3. HOW TO ENTER:** Eligible participants must login or register at Albertine.com (via a secure Bookwitty account) and vote during the Contest Period. To register, go to <u>albertine.com</u> and choose "sign up". To login, go to <u>albertine.com</u> and choose "login". To vote, go to <u>albertine.com/albertine-prize</u> and click "VOTE" under any of the finalist titles. If not already logged in, choose the "LOGIN/REGISTER" option to create an Albertine account via Bookwitty. Each participant who votes during the Contest Period (between April 14, 2017 at 11:59 PM EST and April 30, 2017 at 11:59 PM EST) using a secure Bookwitty account will be entered into the drawing pool one time, regardless of the number of times that account user votes within the voting period. Votes must be received by 11:59 PM EST on April 30, 2017. Use of any automated system to submit votes is prohibited and will result in disqualification. Each voter may utilize only one Albertine user account via Bookwitty during the Contest Period. Utilization of more than one user account per individual entry will result in disqualification from Contest.
- **4. USE OF DATA.** Sponsor will be collecting personal data about participants (including, without limitation, name, date of birth, e-mail address, zip code) when they enter the Contest online. By participating in the Contest online, entrants hereby agree to all personal information uses and disclaimers as explained in Sponsor's privacy policies at this link: https://accounts.bookwitty.com/pages/privacy-policy
- **5. WINNER SELECTION/NOTIFICATION:** Each entrant must comply with all terms and conditions set forth in these Rules, and winning is contingent upon fulfilling all requirements. A voter will be selected at random from the pool of voters who participated in the Albertine Prize second round voting period. Selected winners will be notified by e-mail via the email address associated with the winner's Albertine account. In the event that the e-mails are not responded to or returned as undeliverable, Sponsor will attempt to re-send said e-mail up to two (2) times over

two (2) days. If a Winner does not respond to said email within two (2) days of its transmission or should the e-mail after two (2) attempts be returned as undeliverable, his or her rights to any prize will be forfeited and an alternate entrant will be selected in his or her place at random from all eligible entries received. Potential prize winners will be required to sign an Affidavit of Eligibility and Liability/Publicity Release ("Release") and assignment of Rights ("Assignment") within ten (10) days after the notification date, which will require verification of Social Security number for tax purposes and an IRS Form as well as Evidence of Ownership and Required Permission forms ('Forms") from Third Party Participants or others as determined in the sole discretion of the Sponsor. Failure to supply the requested information or complete the necessary forms will result in forfeiture of all rights to the prize and the selection of an alternate winner. Upon contacting a potential winner and determining that he/she has met all eligibility requirements of the Contest, including without limitation the execution of required waivers, Releases, Assignments and any other required documentation, including Evidence of Rights, such individual will be declared the "Winner" of the Contest. Winner's travel companion may also be required to sign a Companion Release prior to travel. PRIZE DESCRIPTION: The Winner will receive two (2) Air France round-trip Economy class tickets (one set of round-trip tickets for Winner, one set up round-trip tickets for travel companion) from New York (JFK) to Paris (CDG or ORY), France, which has an approximate retail value of \$4,000. Winner will be provided with an IRS Form 1099 specifying the cash value of the prize awarded.

Relative to the Air France round-trip Economy class tickets, Winner and Travel Companion must depart from New York (airport code: JFK). The return flight must originate from Paris (CDG or ORY). Air France round-trip Economy tickets are only valid for Air France operated flights (i.e. no codeshares) and may not be applied towards accruals for any frequent flyer or similar-type program. Actual retail value of tickets may vary based on fluctuations in prices for airfare. Air travel must be prescheduled by Air France within six (6) months before departure and cannot be modified once issued. Tickets must be issued and used between May 1, 2017 and April 30, 2018.
